NOTICE INVITING TENDER

The Consulate General of India, Guangzhou invites Tender under two bid system from registered and authorized firms/agencies for providing Cleaning services at 14th Floor, HNA Tower, 8 Linhe Zhong road, Tianhe district, Guangzhou, China as per details given in the tender documents.

2. The interested firms/service agencies should submit the bids in two separate sealed covers, superscribed as "Technical Bid" and "Financial Bid". Both sealed covers should be put in a separate single envelope superscribed as "Tender No. GUAN/Admn/867/01/2024 for AMC for Cleaning services at the Consulate General of India, Guangzhou" and addressed to the "Head of Chancery, Consulate General of India, 14th Floor, HNA Tower, No. 8 Linhe Zhong road, Tianhe district, Guangzhou, China". Please note that tender document will not be accepted after the expiry of stipulated date and time under any circumstances.

3. Bid Securing Declaration, as per the format enlcosed at **Annexure-I**, is also required to be submitted.

4. The Technical Bids will be opened on **14 January, 2025** by a Committee authorized by the Competent Authority of the Consulate General of India, Guangzhou. The financial bids of only those bidders, whose Technical Bids are found responsive, shall be opened by the Committee authorized for the purpose. The pre-bid site visit may be conducted from **24 – 31 December, 2024** on prior appointment basis to assess the job requirement / quantum of work involved. 1. <u>GENERAL INSTRUCTIONS</u>

- 1.1 For the Bidding / Tender Document Purposes, the Consulate General of India, Guangzhou shall be referred to as 'Client' and the Bidder/Successful Bidder shall be referred to 'Contractor and / or Bidder or interchangeably.
- 1.2 The tender document can be downloaded from the websites of <u>http://www.eprocure.gov.in, https://www.cgiguangzhou.gov.in/tenders/</u> from 24 December, 2025 onwards. The last date of submission of bids is 13 January, 2025.
- 1.3 While all efforts have been made to avoid errors in the drafting of the tender documents, the Bidder is advised to check the same carefully. No claim on account of any errors detected in the tender documents shall be entertained.
- 1.4 The bidder shall submit the copy of the authorization letter / Power of Attorney as the proof of authorization for signing on behalf of the Bidder.
- 1.5 All Bidders are hereby explicitly informed that conditional offers or offers with deviations from the conditions of Contract, the bids not meeting the minimum eligibility criteria, Technical Bids not accompanied by BSD, or any other requirements, stipulated in the tender documents are liable to be rejected.
- 1.6 The bid shall be neatly arranged, plain and intelligible. Each page of the bid should be signed. They should not contain any terms and conditions, printed or otherwise, which are not applicable to the tender. The conditional bid will be summarily rejected. Insertions, postscripts, additions and alterations shall not be recognized, unless confirmed by bidder's signature.

- 1.7 The Parties to the Contract/Agreement shall be the successful bidder (to whom the work has been awarded) and the Client, Consulate General of India, Guangzhou.
- 1.8 For all purposes of the contract including arbitration thereunder, the address of the bidder mentioned in the bid shall be final unless the bidder notifies any change of address by a separate letter handed over personally/courier or by email to the Consulate General of India, Guangzhou. The bidder shall be solely responsible for the consequences of any omission or error to notify any change of address in the aforesaid manner.
- 1.9 The bidders are required to visit the site to assess the quantum of work involved before submitting the tender. Once the tender is submitted, it will be presumed that the bidder has seen and understood the complete work involved.

2. <u>Scope of Work</u>:

2.1. Sweeping/mopping/dusting/vacuum cleaning of common areas, officerooms, toilets, lobbies, window panes, office furniture/equipment, entrance and exit areas and any other place within the premises as directed by the competent authorities from time to time including removal of waste material. This will include the following:

- (i) Daily mopping/ dusting/ vacuum on week days (Monday to Friday) of all office rooms, reception, common areas, carpet floors, pantry, glass doors in the Chancery premises.
- (ii) Collection and removal of all garbage and its disposal in a hygienic manner, including dumping at the designated garbage dustbin of the HNA building.
- (iii) Cleaning of all glass windows /walls once a week or as and when directed and required.
- (iv) Polishing of signages/ nameplates etc to be done once a week or as required.
- (v) Deep cleaning of the multi-purpose hall and Visa hall of the Consulate twice a month.
- (vi) Cleaning of any other place within the premises as directed by the competent authorities from time to time including cleaning during special functions/ parties organized by the Consulate within the building or at the India House.

- (vii) Bids should include cost of cleaning equipment and cleaning material including vacuum cleaner, garbage bags, surface cleaners, air fresheners, brasso, insect killers etc.
- (viii) The working hours will be from 0830 to 1730 hrs (with 01 hour lunch break). In addition to the regular working hours on working days, company will provide cleaning service as and when required, irrespective of the day of the week including weekends/ holidays and before and after office hours on working days. No extra remuneration would be paid to the agency for working on Saturdays/ Sundays/ Holidays (if required).
- (ix) The bidder is required to maintain highest level of cleanliness in the Chancery premises. The cleaners should be provided with proper working Uniforms which are to be worn compulsorily during the entire working time.
- (x) The bidder shall ensure compliance of local laws related to the workers engaged for the above-mentioned work.
- 2.2. Garbage Collection: Garbage will be collected from each room everyday. The collected garbage should be periodically disposed off in accordance with the relevant regulations of HNA building Administration. No garbage shall be allowed to be accumulated in the building. Garbage trolley should be provided by the bidder. All dustbins in office should be provided with suitable garbage bags.

3. <u>MINIMUM ELIGIBILITY CRITERIA</u>

The bidder should have a minimum of 05 years experience in the field of providing cleaning services to other official/ commercial buildings/ offices. The bidder should provide valid permit/registration from the local authorities in Guangzhou for providing cleaning services. The bidder should be able to deploy experienced cleaning staffs (in proper uniform) on all working days (from 0830 Hrs to 1700 Hrs).

4. VALIDITY OF BIDS

- **4.1** Bids shall remain valid and open for acceptance for a period of 180 days from the last date of submission of Bids.
- **4.2** In case, client calls the bidder for negotiation then this shall not amount to cancellation or withdrawal of original offer which shall be binding on the bidder.
- **4.3** The client may request for extension for another period of 60 days, without any modifications and without giving any reasons thereof.

4.4 PRE-BID MEETING/SITE VISIT: Interested firms/service agencies may visit the site for visualization and better understanding of the quantum of work during 24 to 31 December, 2024 after fixing a prior appointment. A pre-bid meeting will take place on 02 January, 2024. The site address is 14th Floor, HNA Tower, No. 8, Linhe Zhong road, Tianhe district, Guangzhou, China. The bidders may also submit their queries by email on the aforementioned email IDs which will also be discussed in the pre-bid meeting.

6 PREPARATION OF BIDS

- 6.1 **Language**: Bids and all accompanying documents shall be in **English** only. The technical as well as the financial bids should be submitted in two sets one original and one copy.
- 6.2 <u>Technical Bid</u>: Technical Bid should be prepared as per the instructions given in the Tender Documents along with all required information, documents in support of the minimum eligibility criteria. All the documents comprising the Technical Bid shall be put in a separate sealed envelope superscribed as "Envelope A Technical Bid". Documents comprising the Bid:
 - **a.** Technical Bid Submission Form duly signed and printed on Company's letterhead.
 - **b.** Contact Details Form, duly filled and signed & stamped.
 - **c.** All attested supporting documents in proof of having fully adhered to minimum eligibility criteria as referred in Section-3 above.
- 6.3 <u>Bid Security Declaration</u>: Bid Security Declaration (BSD) as per format at Annexure-I to be submitted separately in a sealed envelope superscribed as "Envelope B Bid Security Declaration".
- 6.4 <u>Financial Bid</u>: Bidder shall prepare the Financial Bid in the Price Schedule as provided in the Tender Document. Financial Bid shall be put in a separate sealed envelope superscribed as "**Envelope C- Financial Bid**".

7. <u>SUBMISSION OF BIDS</u>

7.1 The Bidding firms have to submit the tenders in two bid system {i.e (i) Technical Bid and (ii) Financial Bid} in the prescribed proforma. Tenders are to be submitted to 14th Floor, HNA Tower, No. 8 Linhe Zhong road, Tianhe district, Guangzhou, China. All the documents in support of eligibility criteria etc. and other required documents are to be submitted along with the Tender Documents. No Tender Documents will be accepted after the expiry of stipulated date and time for the purpose under any circumstances whatsoever.

The tender shall be submitted in sealed envelopes as described below:

7.2 No Bid shall be accepted after the specified date and time. However, the Competent Authority in the Consulate General of India, Guangzhou reserves the right to extend the date / time for submission of bids, before opening of the Technical Bids.

8. <u>BID OPENING PROCEDURE</u>

- 8.1 The Technical Bids (Envelope A) shall be opened at the Chancery premises of the Consulate General of India, Guangzhou in the presence of bidders or their representatives and the Tender Evaluation Committee constituted by the Competent Authority of the Consulate General of India, Guangzhou. After evaluation of Technical Bids, a list of qualified bidders will be prepared by the Consulate General of India, Guangzhou. The Financial bids (Envelope 'C') will be opened on a subsequent date, which will be intimated to the shortlisted bidders, by e-mail/ phone.
- 8.2 Bids shall be declared as valid or Invalid based on the preliminary scrutiny, i.e. on site verification of documents submitted by the bidders by the Tender Evaluation Committee. The financial bids will be opened on result of such scrutiny. However, in case any thing found false or forged in contrary to the documents submitted by the bidder, its bid will be rejected and suitable legal action may be taken.
- 8.3 The Financial Bids of only those bidders, who qualify at Technical Bid stage, shall be opened by the Committee authorized for the purpose. Those bidders who qualify in the technical bid stage, will be intimated through mail/phone about the date for opening of the Financial Bids.
- 8.4 The date fixed for opening of bids, if subsequently declared as holiday by the Government, the revised date of schedule will be notified. However, in absence of such notification, the bids will be opened on next working date, the time remaining unaltered.
- 8.5 A letter of authorization shall be submitted by the Bidder's representatives before opening of the Bids.
- 8.6 Absence of bidder or their representative shall not impair the legality of the opening procedures.
- 8.7 After opening of the Technical Bids, the technical bids shall be evaluated to ensure that the bidder meets the minimum eligibility criteria as specified in the Tender Document.

9. CLARIFICATION ON TECHNICAL BID EVALUATION.

9.1 The Technical Bids shall be evaluated based on the available documents submitted by the bidder. To assist in the examination, evaluation, and comparison of the bids, and qualification of the bidders, the client may, at its discretion, ask any bidder for a clarification of its bid. Any clarification submitted by a bidder that is not in response to a request by the client shall not be

considered. The client's request for clarification and the response shall be in writing.

- 9.2 If a bidder does not provide clarifications of its bid by the date and time set in the client's request for clarification, its bid may be rejected.
- 9.3 Client also reserves the right to seek confirmation/clarification from the issuer agency, on the supporting documents submitted by the bidder.

10. <u>PERFORMANCE SECURITY (PS):</u>

- 10.1 The successful bidder has to deposit Performance Security which will be RMB 5,000/- in favour of the 'Consulate General of India, Guangzhou' in form of Demand Draft / Pay Order/Bank Guarantee within fifteen days of the acceptance of the Letter of Award (LoA). Performance Security should remain valid for a period of sixty (60) days beyond the date of completion of all contractual obligations of the service provider (SP). In case, the contract is further extended beyond the initial period, the Performance Security will have to be renewed accordingly by the SP. No interest shall be paid on Performance Security.
- 10.2 The Performance Security will be forfeited by order of the Competent Authority in the Consulate General of India, Guangzhou in the event of any breach or negligence or non-observance of any terms & conditions of the contract or for unsatisfactory performance or for non-acceptance of the work order. On expiry of the contract, portion of the Performance Security, as may be deemed fit by the Client sufficient to cover any incorrect or excess payments made on the bills to the firm, shall be retained until the final audit report on the account of Contractor's bill has been received and examined.
- 10.3 If the Contractor fails to provide the Performance Security within fifteen days of the acceptance of LoA, such failure shall constitute a breach of the contract and the Client shall be free to make other arrangements at the risk, cost and expense of the Contractor.
- 10.4 On due performance and completion of the contract in all respects, the Performance Security will be returned to the SP without any interest on presentation of an absolute 'No Demand Certificate' from the SP and upon return in good condition of any specifications, samples or other property belonging to the client, which may have been issued to the SP, for carrying out work stipulated in the contract.

11. VALIDITY OF CONTRACT

The contract, if awarded, shall be valid for a period of <u>ONE YEAR</u> (01 year). The contract may be extended annually on year to year basis, for further 02 years [maximum tenure 03 years from the date of start of work initially] as per the contract signed on same terms and conditions and same rates, subject to

satisfactory services provided by the vendor. In case of breach of contract or in the event of not fulfilling the minimum requirements /statutory requirements, the client shall have the right at any time to terminate the contract forthwith in addition to forfeiting the performance security amount deposited by the Contractor and initiating administrative actions for blacklisting etc. solely at the discretion of the competent authority in the Consulate General of India, Guangzhou.

12. <u>PAYMENTS</u>

- 12.1 After award of work, the bills for the services for a month must be prepared based on the approved rates and submitted to the Consulate on monthly basis by the 10th of the succeeding month for effecting payment. The payment will be made within 10 working days after receipt of invoice from the company and satisfactory completion of job.
- 12.2 The bills should be inclusive of applicable taxes as may be levied by the local Government from time to time.
- 12.3 All payments shall be made in Renminbi by bank transfer.
- 12.4 The Client shall be entitled to deduct in accordance with applicable law, Income Tax or withholding tax or other deductions (as the case may be), from any payments made to the Contractor, and the amount so deducted shall be deemed to be a payment made to the Contractor.
- 12.5 The payment to the workers in accordance to minimum wages prescribed by the local Government along with the statutory compliance Bonus is sole responsibility of the Contractor. In case of revision in minimum wages by the local Government, the same would be absorbed by the service provider. Claim for any escalation shall not be entertained by the Client.
- 12.6 No request for revision/ increase of approved rates during the currency of the contract will be entertained.
- 12.7 No payment shall be made in advance nor will any loan from any bank or financial institution be recommended on the basis of the order of award of work.

13. <u>Other Conditions, Force Majeure & Penalty Clause</u>

- 13.1 The cleaning staff so provided should be on the roll of the Company.
- 13.2 The bidder must have satisfactory arrangements for training of its workers. Confirmation in this regard is to be given.
- 13.3 The cleaning staff engaged by the bidder will be the employees of the bidder and the Consulate will not, in any way, be responsible for any liability/ compensation

on account of accident, injury or death of workers while performing their work inside the Consulate premises.

- 13.4 The bidder shall employ in consultation with the Consulate only those persons who are physically and medically fit and whose antecedents have been verified and cleared by the local police/ Administration.
- 13.5 The bidder should submit precise profile of its key clients alongwith details of services provided.
- 13.6 If any cleaner is absent on a given day, the company will provide a substitute for him otherwise proportionate deductions will be made from the monthly payment.
- 13.7 In case the Service Provider fails in adhering to the daily cleaning requirements at the Consulate's premises and Client has to make alternative arrangements for daily cleaning, then Service Provider would reimburse the cost of such arrangements.
- 13.8 Contractor would be fully responsible for all acts of omission or negligence, dishonesty or misconduct of its employees for work at the Consulate's premises. Contractor would indemnify Client against any compensation/claim and damages etc. due to accident or injury to its employees or death due to accident or otherwise, which may arise out of and during the course of their duties. Client would not be liable to pay any damages or compensation to such cleaners or to any third party.
- 13.9 In case of any complaint, either as regards the nature of service or as regards the behaviors of cleaners on duty or otherwise, Contractor would be intimated and would be required to take corrective measures promptly.
- 13.10 Client reserves the right to amend/withdraw any of the terms and conditions in the tender documents or to reject any or all tenders without giving any notice or assigning any reason. The decision of the Client in this regard shall be final and binding on all.
- 13.11 Client reserves its right to revoke the contract at any time, if the services rendered are not found satisfactory during the period of the contract.
- 13.12 Client may, by written notice sent to Cleaning agency, terminate the contract, with a notice period of at least one month, in whole or in part at any time for its convenience. The notice of termination shall specify that termination is for the Client's convenience, the extent to which performance of work under the contract is terminated and the date upon which such termination becomes effective.
- 13.13 The bidder must have modern equipment(s), latest technical expertise for management of buildings and related facilities, as has been defined in brief scope of work. Machinery, equipment, implements, material and consumables proposed to be used should be clearly indicated. List of equipment owned by the company may also be furnished with the bid.

- 13.14 Any wrong or misleading information will lead to disqualification.
- 13.15 The bidder shall maintain at all times machinery / equipment and other resources required for upkeep and cleanliness of the premises of the Client. The SP will arrange at his own cost additional machinery/ equipment and resources if required by the Client for the purpose.
- 13.16 Client reserves the right to remove any person found unfit.
- 13.17 The bidder would be responsible for all mandatory compliance for social, safety and environmental issues related to the performance of the service provider in the Consulate's premises as stated in the eligibility criteria.

NOW THIS AGREEMENT WITNESSTH as follows:

AND WHEREAS the Client desires that the cleaning services (as defined in the Bidding Document) be provided, performed, executed and completed by the Contractor, and wishes to appoint the Contractor for carrying out such services at the monthly charges of ______ for an initial period of one year from _______ to ______ to ______, extendable for further two years on yearly basis at the same rates and terms & conditions, subject to satisfactory performance by the Contractor.

AND WHEREAS the Contractor acknowledges that the Client shall enter into contracts with other contractors / parties for the housekeeping services of its premises in case the Contractor falls into breach of the terms and conditions as stipulated in the Tender Document and shall waive its claim whatsoever in this regard,

AND WHEREAS the terms and conditions of this Contract have been fully negotiated between the Client and the Contractor as parties of competent capacity and equal standing.

AND WHEREAS the Contractor has fully read, understood and shall abide by all the terms and conditions as stipulated in the Tender Documents for providing housekeeping services in the Client's premises, failing which the Contract is liable to be terminated at any time, without assigning any reasons by the Client.
